### **ATV Requirements:**

- Must be no more than 50"
- Must have dry weight of 1,500 lbs or less
- Must travel on three or more non-highway tires
- Must have a seat to be straddled by operator

### **UTV Requirements:**

- Must be at least 48" in width
- Must not be more than 135" in length
- Must have bench or bucket seating
- Must have 4 or more low pressure tires

### **Golf Cart Requirements:**

- Not less than 3 wheels
- Not operated at more than 25 mph
- Not designed to carry more than 4 people
- Must not weigh more than 1,800 lbs

### **Micro Utility Truck Requirements:**

- Not less than 48" in width
- Can exceed 40 mph
- Manufactured with a metal cab

**DRIVER'S OF ANY OF THE ABOVE MUST HAVE A VALID DRIVER'S LICENSE TO OPERATE THE VEHICLE**  
VEHICLE'S CAN NOT BE DRIVEN ON TRAPP STREET OR SOUTH 5<sup>TH</sup> (HWY 56) IT IS A STATE HIGHWAY. YOU MAY  
ONLY CROSS TRAPP STREET OR SOUTH 5<sup>TH</sup>.

Permit is not transferable and is only good for the City Limits of Herington. Insurance must be carried on this  
vehicle and have proof available while driving the vehicle.

**IF NO HEAD LIGHTS, TAIL LIGHTS, BRAKE LIGHTS OR BLINKERS VEHICLE CAN NOT BE DRIVEN AFTER SUNSET.**

**GOLF CARTS CAN NOT BE DRIVEN EVER AFTER SUNSET WHETHER EQUIPPED WITH LIGHTS OR NOT.**
