Regular Meeting May 17, 2022 6:00 p.m.

The Herington City Commission met on the above date and time in the Commission Chambers at City Hall. In attendance were Mayor Eric Gares, Commissioner Vance Donahue, Commissioner Debi Urbanek, Commissioner Robbin Bell and Commissioner Castleberry. Also in attendance were City Manager Branden Dross, City Attorney Brad Jantz, City Clerk Megan Lawrenz, Larry Mann, Carl Urbanek and Nick Acheson.

The meeting opened with the pledge of allegiance.

Mayor Gares called the meeting to Order.

Commissioner Bell made a motion to approve the minutes from the regular city commission meeting on May 3, 2022, seconded by Commissioner Donahue. Motion carried 5-0.

Public Forum – None.

Additional Agenda Items – Add 14a Ordinance and 14b Resolution.

Approval of Agenda - Commissioner Donahue made a motion to approve the agenda with the addition of 14a and 14b, seconded by Commissioner Bell. Motion carried 5-0.

City Clerk Update – City Clerk Megan Lawrenz provided the Commissioners with March and April 2022 financial documents. Also, discussed the audit findings.

Introduction

Herington Lakes has served the City of Herington's recreational, and infrastructure needs since the original lake was dammed in 1923. Since their inception, the lakes were utilized to serve as the City's water supply. Today the lakes serve the City's population of 2,147 residents in addition to tourists on a yearly basis that come to utilize the lakes amenities including RV camp sites, tent camping sites, beach areas, fishing docks and pavilions. Implementation of this Master Plan would be one of the most significant parks and recreation investments in the region. The facilities recommended for the two lakes will provide users with a broad range of activities for all ages and abilities. Improvements of both parks will not only provide residents access to recreational amenities currently unavailable to them, but also serve as a catalyst for drawing tourists to the area for camping, festivals, and recreational opportunities. The addition of these facilities will enhance the quality of life for residents and visitors for years to come.

Purpose

For nearly 100 years, the 1,560 acres that comprise the Herington Lake Parks have served residents as a source of both household drinking water and recreation. Over the years, a variety of changes have impacted the lake function and character. Events that were once possible, including boat races are no longer possible due to the siltation of the lake. In addition, with the shallow water in the original lake, algae blooms in the heat of the summer are more common, limiting the ability to use the lake for recreational opportunities. Tourists and users today also expect quality amenities to draw people to these facilities. The lakes serve as a unique destination that can draw users throughout the region with updated facilities.

To continue the City of Herington's excellence in providing its residence with recreational opportunities and activities, the City commissioned the new Herington Lakes Park Master Plan in 2021. After issuing a Request for Proposals (RFP) and conducting interviews, Confluence was selected. The team was tasked with creating a vision for this facility that provides a wide range of recreation and activity spaces. The plan establishes a vision for the parks combining community input and desires with a holistic and environmentally responsible approach.



Process

The design process began with the Design Team and Steering Committee members completing a "Walk the Park" analysis on November 3rd, 2021. This step in the master planning process allowed for both the Design Team and client group to gain an in-depth knowledge and understanding of the various aspects of the park sites. This also provided input to the Design Team regarding maintenance, operations, and programming of the current park facilities.

Following the site walk, the group gathered at Herington City Hall for continued discussion and a summary of the site walk. The group also participated in a 'Dot Exercise', where they prioritized the program elements, architectural aesthetic and signage character to guide development of the Herington Lakes Master Plan. The information gathered, along with research, extensive public input and information from the site inventory, was then used as a tool to guide the design recommendations for the master plan.

Goal and Vision Statement

The next step in the design process was for the Design Team and City Staff to develop Goal and Vision Statements as a means to set a level of expectation for these important projects and to become the guiding principles for the project. Design options and recommendations were weighed against the Goal and Vision Statements as a means to validate their ability to meet the expectations set forth.

GOAL:

To create a destination unique to the central Kansas region drawing a multi-generational population of Herington community residents and tourists for memorable and repeated visits while still preserving and sustaining the existing ecological character.



VISION STATEMENTS:

- 1. Capitalize on partnerships with the local schools, county, community businesses and public-private partnerships to accelerate phasing opportunities and create a regional and economic draw.
- 2. Establish a sustainable and maintainable vision for the parks that create community buy-in and establish the park as a regional tourist destination.
- 3. Develop an aesthetic that is complementary to the existing park character to create a memorable and iconic experience for all users while incorporating experiences on and adjacent to the water.

Benchmarking Analysis

The next step in the design process was to begin the process of "Understanding the Market." A "Comparative Analysis" of six similar facilities within the region was conducted to understand and identify facilities or programs to be considered in order for each park to become a unique regional destination which provides one of a kind recreational opportunities. Finding this "sweet spot" that incorporates amenities unseen throughout the other parks increases the regional draw of the parks for extended uses.

Committee/Public Input Findings

On December 8, 2021, the Design Team gathered additional input through a public workshop at the Herington Community Building. This open house format gave participants the opportunity to provide their input regarding preferred amenities and programs for the parks. Additional feedback was gathered related to amenity location and surrounding context of the properties around the park. Participants were polled on preferences of program, architectural character, signage/wayfinding and public art. Results were utilized to develop a preferred program for the two initial concepts.

Following the input meeting with the public, additional feedback was solicited input from students at Herington High School. The additional responses were added to the public input to verify overall direction for program and amenities to be considered in the parks concept plans.



Upon completion of the site review and various programming workshops, the Design Team developed two master plan alternatives for Herington Lakes. The plans were then presented at a workshop on March 1st, 2022. The public was invited to provide their thoughts regarding each of the proposed master plan alternatives and the facilities and programs each provided. Those attending the workshop were also encouraged to provide any additional thoughts and ideas via email.

Common facilities and program elements were found between plan alternatives based on the activities desired within the park. The results of the input gathered are shown below:







Master Plan

Project Capital/Funding

RESOLUTION NO. 957

A RESOLUTION GRANTING TEMPORARY EXEMPTION FROM THE REQUIREMENTS OF CHAPTER 5, ARTICLE VI, SECTION 5-601 ET. SEQ. OF THE HERINGTON CITY CODE, REGULATING THE RETAIL SALE OF FIREWORKS WITHIN THE CITY LIMITS OF THE CITY OF HERINGTON, DICKINSON COUNTY, KANSAS.

WHEREAS, the City of Herington, Kansas generally regulates and specifies approved zones and property for the retail sale of fireworks within the city limits; and,


WHEREAS, the Governing Body desires to allow for temporary exemptions from such regulation as authorized in the Herington City Code, Chapter 5, Article VI, Section 5-603(b) by resolution lawfully approved by majority vote of the governing body; and,

WHEREAS, the Governing Body has received a request for exemption for the sale of fireworks in a zone not originally authorized in the Herington City Code, Chapter 5, Article VI, Section 5-603(a) deems it appropriate to allow for a temporary exemption.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF HERINGTON, KANSAS:

- 1. The Governing Body hereby finds that a temporary exemption should be granted for the retail sale of fireworks as authorized and regulated in the Herington City Code, Chapter 5, Article VI, Section 5-601 et. seq. on certain property within the city limits of Herington, Kansas, identified in paragraph 2 of this resolution.
- 2. The exemption shall apply only to a clearly defined and secure area in and on the area with the address of 700 S. Broadway, Herington, Kansas currently bearing a zoning designation of "A-1", within the city limits of the City of Herington, Kansas. Such defined area as established, and any signage or surrounding security barriers identifying the prescribed area, shall be approved in advance by the Herington Fire Chief.
- 3. The exemption for the retail *sale* of fireworks only, shall be allowed on June 27, 2022 through July 5, 2022 from 12:00 p.m. until 11 p.m. at which time such temporary exemption shall expire.

RESOLUTION NO. 956

A RESOLUTION GRANTING TEMPORARY EXEMPTION FROM THE REQUIREMENTS OF CHAPTER 3, ARTICLE II, SECTION 3-204 PROHIBITING CONSUMPTION OF ANY ALCOHOLIC LIQUOR OR ENHANCED CEREAL MALT BEVERAGE ON PUBLIC PROPERTY WITHIN THE CITY LIMITS OF THE CITY OF HERINGTON, DICKINSON COUNTY, KANSAS.

WHEREAS, the City of Herington, Kansas generally prohibits consumption of alcoholic liquor or enhanced cereal malt beverages on public property within the city limits; and,

WHEREAS, the governing body desires to allow for temporary exemptions from such a general prohibition by resolution lawfully approved by majority vote of the governing body; and,

WHEREAS, the governing body has received a request for exemption for a public event to be held on city property and deems it appropriate to allow for a temporary exemption.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF HERINGTON, KANSAS:

- 1. The governing body hereby finds that a temporary exemption should be granted for possession and consumption of any cereal malt beverage including enhanced cereal malt beverages defined as having an alcohol concentration of no more than 6.0% by volume and alcoholic liquor, on certain public property identified in paragraph 2 of this resolution.
- 2. The exemption shall apply only to a clearly defined, fenced and secure area in and on the area commonly known as the Herington Fairgrounds within the city limits of the City of Herington, Kansas. Such defined area as established, and any signage or surrounding security barriers identifying the prescribed area, shall be approved in advance by the Herington Police Chief.
- 3. The exemption shall be allowed on Sunday July 8, 2022 from 5:00 p.m. until 11:59 p.m. and again on Saturday, July 9, 2022 until 11:59 p.m. at which time such temporary exemption shall expire.
- 4. Such exemption shall apply for the possession and consumption of enhanced cereal malt beverages only, defined as having an alcohol concentration of no more than 6.0% by volume.

All necessary permits authorizing the possession, and consumption of any cereal malt beverage including enhanced cereal malt beverages defined as having an alcohol concentration of no more than 6.0% by volume, shall be timely applied for and granted by the appropriate licensing agency in advance of the noted date herein as a precondition for award of this exemption.

Synopsis:

In the absence of a public purpose, a city cannot rent city equipment to private individuals for private use. Cited herein: Kan. Const., Art. 12, § 5.

Dear Mr. Hirsch:

You request an opinion regarding the ability of a city to rent city equipment to individuals for private purposes. You indicate that the City of Oberlin rents bucket trucks, backhoes and other city equipment to private citizens as well as city employees for private use.

Prior to 1960, Kansas appellate courts generally disapproved of a city's leasing public property to individuals for private purposes because such action violated "Dillons Rule." Dillons Rule prohibited municipal corporations from exercising any powers except those expressly granted by the Legislature or incident to the powers expressly granted. In a series of cases, the Kansas Supreme Court held that cities had no statutory authority to lease publicly financed buildings to private individuals for private purposes. Moreover, in a case involving a city leasing part of a military memorial building to an individual who operated a movie theatre, the Court opined that even if such authority existed, it would offend public policy that frowned on cities engaging in commercial endeavors:

"Aside from the consideration that the statute does not expressly or impliedly authorize municipalities to carry on the business in which defendants are engaged, we think that it is repugnant to our state policy as evidenced by the constitutional, statutory and common law of the state." ['It] has been the policy of our government to exalt the individual rather than the state, and this has contributed more largely to our rapid national development than any other single cause. Our constitution was framed and our laws enacted with the idea of protecting, encouraging and developing the individual enterprise, and if we now intend to reverse this policy and to enter the state as a competitor against the individual in all lines of trade and commerce, we must amend our constitution and adopt an entirely different system of government." (3)

The Home Rule Amendment (4) to the Kansas Constitution trumped Dillons Rule by specifically empowering cities to "determine their local affairs and government," (5) by enacting

ordinary ordinances provided that state law does not preempt or conflict with local legislation. In Attorney General Opinion No. 87-88, Attorney General Robert T. Stephan concluded that the Home Rule Amendment allowed a city to lease public park land to a private individual for the development of a recreational facility provided that there was a public purpose in doing so.

Regarding the propriety of cities engaging in commercial enterprises, General Stephan noted, in another opinion, that while prior court decisions had prohibited political subdivisions from engaging in commercial enterprises, there is no objection when a public purpose is demonstrated. (6)

We find no statutes that specifically address a city's authority to rent equipment such as backhoes and bucket trucks to individuals for private use. Therefore, it is our opinion that the Home Rule Amendment would allow a city to do so. However, a city cannot escape its obligation to ensure that renting city equipment to private individuals for private use is for a public purpose.

The seminal cases that address a municipality's use of public funds for a public purpose are *Ullrich v. Board of County Comm'rs of Thomas County* (7) and *Duckworth v. City of Kansas City, Kansas.* (8) In *Ullrich*, the Kansas Supreme Court upheld a statute authorizing the transfer of assets from the county hospital to a private association because such transfer was for a public purpose. The Court recognized that a state may appropriate public money or *property* for private individuals if the public welfare is promoted. "If the purpose of the expenditure of public money is legitimate because for a public purpose, it will not be defeated because the execution of it involves payments to individuals or private corporations." (9) Moreover, the Court opined that it would defer to the governing body the question of what is a public purpose:

"What is for the public good or what are public purposes for which appropriations may be made are questions which the legislature must in the first instance decide. In determining those questions, a state legislature is vested with a broad discretion, which cannot be controlled by the courts, except when its action is clearly evasive or violative of a constitutional provision. It has been said that a strict formula to determine public purposes for all times cannot be formulated, since the concept expands with the population, economy, scientific knowledge, and changing conditions. As people are brought closer together in congested areas, the public welfare requires governmental operation of facilities which were once considered exclusively private enterprises, and necessitates the expenditure of tax funds for purposes which were not classified as public.

"What is a public purpose for which public funds may be expended is not a matter of exact definition, and the line of demarcation is not immutable or incapable of adjustment to changing social and economic conditions that are properly of public and governmental concern." (10)

In *Duckworth*, the Court, citing *Ullrich*, concluded that the City of Kansas City could loan public moneys to an individual who planned to use the funds to remodel a building in the blighted downtown area. The Court noted the City's resolution authorizing the loan stated that the purpose was to revitalize the central business district by improving the appearance of the neighborhood which the Court found to be a legitimate public purpose.

In Attorney General Opinion No. 93-1, Attorney General Robert T. Stephan concluded that, absent a public purpose, a county could not contract with an individual to provide county personnel and equipment to perform private road work.

We do not have any information concerning the City of Oberlin's practice of renting equipment to private individuals for private uses and, therefore, we cannot opine regarding whether such use is for a public purpose. In the absence of a public purpose, it is our opinion that a city cannot rent city equipment to private individuals for private use.

You also inquire whether the public purpose doctrine distinguishes between moneys generated from general tax funds and moneys derived from other kinds of public funds such as utility funds. While there are no Kansas appellate court decisions that address this point, it is our opinion that public funds, regardless of their origin, can only be used for public purposes. Moreover, in some cases, certain public funds can be used only for specified purposes set forth in statute or in other guidelines.

RESOLUTION NO. 955

A RESOLUTION GRANTING TEMPORARY EXEMPTION FROM THE REQUIREMENTS OF CHAPTER 3, ARTICLE II, SECTION 3-204 PROHIBITING CONSUMPTION OF ANY ALCOHOLIC LIQUOR OR ENHANCED CEREAL MALT BEVERAGE ON PUBLIC PROPERTY WITHIN THE CITY LIMITS OF THE CITY OF HERINGTON, DICKINSON COUNTY, KANSAS.

WHEREAS, the City of Herington, Kansas generally prohibits consumption of alcoholic liquor or enhanced cereal malt beverages on public property within the city limits; and,

WHEREAS, the governing body desires to allow for temporary exemptions from such a general prohibition by resolution lawfully approved by majority vote of the governing body; and,

WHEREAS, the governing body has received a request for exemption for a public event to be held on city property and deems it appropriate to allow for a temporary exemption.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF HERINGTON, KANSAS:

- 1. The governing body hereby finds that a temporary exemption should be granted for possession and consumption of any cereal malt beverage including enhanced cereal malt beverages defined as having an alcohol concentration of no more than 6.0% by volume and alcoholic liquor, on certain public property identified in paragraph 2 of this resolution.
- 2. The exemption shall apply only to a clearly defined, fenced and secure area in and on the area commonly known as the Herington Fairgrounds and the South Recreation Complex (including the east and west baseball and soccer fields) within the city limits of the City of Herington, Kansas. Such defined area as established, and any signage or surrounding security barriers identifying the prescribed area, shall be approved in advance by the Herington Police Chief.
- 3. The exemption shall be allowed on Sunday July 3, 2022 from 12:00 p.m. until 11:59 p.m. at which time such temporary exemption shall expire.
- 4. Such exemption shall apply for the possession and consumption of enhanced cereal malt beverages only, defined as having an alcohol concentration of no more than 6.0% by volume.

All necessary permits authorizing the possession, and consumption of any cereal malt beverage including enhanced cereal malt beverages defined as having an alcohol concentration of no more than 6.0% by volume, shall be timely applied for and granted by the appropriate licensing agency in advance of the noted date herein as a precondition for award of this exemption.
