The Board of City Commissioners of the City of Herington, Kansas met at City Hall at 5:30 p.m. on the above date – the following being present: Mayor Debi Urbanek, Commissioner Curtis Hartman, Commissioner Robbin Bell, Commissioner Vance Donahue II, Commissioner Ben Castleberry, City Manager Branden Dross, City Attorney Brad Jantz, City Clerk Megan Lawrenz Chief of Police Chad Langley and Fire Chief Andrew Avantagiato. Also, in attendance were C Orander, D.J. Neuberger, Carl Urbanek, Eric Gares, Larry Mann, Dan McDonald, Christina McDonald, Pam Dalton, Karen Soliz, Janet Wade, Angela Dross and Branden Dross Jr.

The meeting opened with the Pledge of Allegiance.

Commissioner Bell motioned to approve the minutes from the regular meeting October 12, 2021, seconded by Mayor Urbanek. Motion carried 5-0. Mayor Urbanek motioned to approve the minutes from the regular meeting October 19, 2021. Motion failed 0-5. Mayor Urbanek motioned to approve the minutes form the regular meeting October 19, 2021, with the changes requested by Janet Wade to her previous comments, seconded by Commissioner Bell. Motion carried 5-0. Commissioner Bell motioned to approve the minutes from the special meeting October 29, 2021, seconded by Commissioner Donahue. Motion carried 5-0.

Public Forum – D.J. Neuberger – 9 S 2<sup>nd</sup> Herington, KS 67449 – Building Permits. Pam Dalton 609 S B St Herington, KS 67449 – FRE Food Drive/Pie in the City Managers face. Janet Wade – 602 E Arnold Herington, KS 67449 – October 19 minutes if not addressed (the minutes were discussed, and Janet made no comment during Public Forum). Joe Kossmann – 801 N Broadway Herington, KS 67449 – Big Blue.

Additional Agenda Items – City Manager Branden Dross clarified that the applications listed for Lake Board are for the Lake Master Plan Citizen Advisory Committee, and that there will be no term limits. Add 16a. Discussion on Ordinance 1841.

A motion was made by Commissioner Bell, seconded by Commissioner Donahue to approve the agenda with the addition of 16a. Motion carried 5-0.

Police Update – There were 197 calls for service last month and 4 misdemeanor arrests. Chief of Police Chad Langley was in Hutchinson for reciprocity classes and passed. Looking to hire one more officer. Officer Canby will attend teen crisis training on the 18<sup>th</sup>. Chief Langley is looking to move the responsibility of evidence logging to another officer after they complete training. HPD has been patrolling the lake multiple times per day checking for the proper registrations from campers.

Fire Update – There were 34 calls for service. 1 structure fire, 22 medical assists, 6 controlled burns, 1 smoke scare, 1 fire alarm, 1 MVA, 1 cancel and 1 trash/rubbish fire. Training topics were overview of the new air packs, and Chief Avantagiato completed fire investigator CFI1. Air packs will be shipping out 11/12/2021, the neighborhood enforcement officer's car has had several repairs, cost unknown. The

Tahoe is constantly showing Check Engine Codes, going into 4x4 low on start up. The building committee is complete and will hold a meeting within the new couple weeks. Response time is great, under 2 minutes for structure fire, average response for :32 to 2:07, average on scene time 3:63 to 8:12. Chief Avantagiato also spoke about the Recreational Fire Guidelines that the city follows and there was discussion about adding a recreational fire ordinance.

Neighborhood Enforcement Update – The NEO informed the commission that she will be at a conference for the next three days, and that she has 3 upcoming court dates. There was one condemnation, the family called the police twice with concerns of their civil rights being violated. The police department was able to provide the family with the code that corresponds with the process. Letters have been sent for parking on vegetation, some have put gravel down to meet code. The NEO rode around with David Kahle to check electric services, upgrades are needed, and the NEO, City Attorney and City Manager will work together to find solutions to the upgrades needed. The NEO has been working with Council Grove and Junction City on permitting. The NEO also plans to be certified in IPMC before the first of the year. There are currently 17 open cases. The NEO also provided a draft version of a flyer noting whether a permit is needed for specific types of construction.

Comprehensive Plan Regulation Update – City Attorney Brad Jantz said that statutory the City is not absolutely required to replace or reform the Comprehensive plan every so many years, however the standard is that at 5 years the plan is updated or at least reviewed, typically by the planning commission, the city commissioners do have the authority to direct the planning commission to do so. The City Attorney said that while no one would come in and cite the city for a dated comprehensive plan, it could make applying for grants difficult.

#### AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

This Agreement is hereby entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2021, by and between the City of Herington, Kansas, a municipal corporation (hereinafter "City"), and SMH Consultants, a Professional Corporation, (hereinafter "Consultant").

WHEREAS, the City desires to obtain professional engineering services, in connection with the development of a Preliminary Engineering Report (PER) for the City's Wastewater Treatment

Plant (hereinafter "Project") and assistance with a grant application; and,

WHEREAS, Consultant is a professional corporation, with local offices located at <u>2017</u> <u>Vanesta Place, Suite 110, Manhattan, Kansas, 66503</u>, licensed to provide professional engineering services in the state of Kansas; and,

WHEREAS, Consultant is qualified, capable and prepared to perform the necessary professional engineering services in connection with the Project as described in this Agreement; and,

NOW THEREFORE, in consideration of the mutual promises contained herein, the parties agree as follows:

- Preparation of a Preliminary Engineering Report (PER) on the Wastewater Treatment Plant and assistance with a Kansas Department of Commerce - Community Development Block Grant (CDBG) application:
  - A. The term "Services" when used in this Agreement shall mean any and all professional engineering services provided by Consultant in accordance with this Agreement. The Consultant may employ subconsultants as Consultant deems necessary to assist in the performance or furnishing of professional engineering and related services hereunder. The Consultant shall not be required to employ any subconsultants which are unacceptable to the Consultant. The Consultant will perform or furnish the necessary professional services to prepare a PER suitable for application to, and following the required guidelines of, the Kansas Department of Commerce in pursuit of a Community Development Block Grant (CDBG) and assist the City in a CDBG grant application.
  - B. City agrees to retain Consultant and Consultant agrees to perform and complete the

following Services for the Project:

- 1. Evaluate available City records, maintenance history, and historical data documenting the wastewater treatment facility, its age and physical condition, any additions and alterations, and other pertinent data.
- 2. Review and update the estimated construction costs identified in the "Wastewater Treatment Plant Evaluation" conducted in October 2018.
- 3. Following the Kansas Department of Commerce requirements, prepare a PER for submission to the Kansas Department of Commerce and other funding agencies.
- 4. Deliver the required number of copies of the PER to the funding agencies and City.
- 5. Attend a City Commission Meeting to present, discuss, and review the PER.
- 6. Assist the City with scheduling and conducting the CDBG Public Meeting and Hearing. Attend the Public Meeting and Public Hearing.
- 7. Schedule the Kansas Interagency Advisory Committee (KIAC) meeting.
- 8. Along with City representatives, attend a KIAC meeting to present the proposed project.
- 9. Assist the City with the search and procurement of a grant writer for purposes of pursuing a CDBG application.
- 10. Assist the grant writer with the CDBG application.
- 2. Consultant shall provide Services under this Agreement only upon written request of the City, and only to the extent defined and required by the City. Consultant shall not provide any services or materials not described by this Agreement unless Consultant obtains prior written consent from the City. If the City gives prior written consent for Supplemental Services, the City shall compensate Consultant with a fee mutually agreed upon by the parties prior to performance of the Supplemental Services. Any Supplemental services or materials provided by Consultant without the City's prior written consent shall be at Consultant's own risk, cost, and expense, and Consultant shall not make a claim for compensation from the City for such work.

### 3. Standard of Care

- A. Consultant shall exercise the same degree of care, skill, and diligence in the performance of all Services to the City that is ordinarily possessed and exercised by reasonable, prudent, and experienced professional engineer under similar circumstances. At the City's request, Consultant shall re-perform the Services which fail to satisfy this standard of care. If Consultant fails to possess and exercise such care, skill and diligence in providing all Services, Consultant shall be responsible to the City for any resulting loss or damages.
- B. Consultant represents it has all other necessary licenses, permits, and certifications required to perform the Services described herein.
- C. Consultant shall comply with, and make an effort to cause any sub-consultants to comply with, applicable federal, state and local laws, orders, rules and regulations relating to the performance of the Services.
- D. Neither Consultant nor Consultant's agents or employees shall discriminate against any employee or applicant for employment in the performance of this Agreement with respect to hiring, tenure, terms, conditions, or privileges of employment, because of race, color, religion, sex, or national origin.
- 4. City's Responsibilities
  - A. To assist in the completion of the work described above, the City shall:
    - 1. Designate a person to act as the City's representative with respect to the services to be rendered under this Agreement. Such person shall have authority to transmit instructions, receive information, interpret, and define the City's policies and decisions with respect to the Consultant's services.
    - 2. Provide any and all the available information relative to the completion of the Consultant's services.
    - 3. Schedule, properly advertise, and attend all Project meetings, Public Meetings, and Public Hearings.
    - 4. Contract with separate firms, if necessary, to conduct additional investigations or studies to address the Intergovernmental Review comments, if any.
    - 5. Provide any and all the available information relative to the completion of the Consultant's services.

- 5. Compensation & Audit by City
  - A. As consideration for providing the Services as outlined above, the City shall pay Consultant the lump sum fee of <u>\$Sixteen Thousand</u>, Nine Hundred Eighty Dollars and <u>no cents (\$16,980.00</u>). Payment shall be total compensation for labor, overhead, expenses, and anticipated profit.
  - B. Payments shall be requested monthly, based on progress determined by the Consultant. The invoice shall indicate the percentage of the Project completed. City agrees to pay the balance of an approved invoice, or undisputed portions of a disputed invoice, within 30 days of the date of receipt by the City. In the event of a dispute, and prior to the invoice's due date, City shall pay the undisputed portion of the invoice and notify Consultant of the nature of the dispute regarding the balance.
  - C. At the City's request, Consultant shall permit the City, or any authorized representative of the City, at all reasonable times, to access and examine all records, books, papers or documents related to Consultant's performance under this Agreement, including, but not limited to, expenses for sub-consultants, agents or assistants, direct and indirect charges, and detailed documentation for all such work performed.
- 6. Schedule & Delay
  - A. Unless otherwise directed by the City, Consultant shall commence performance of the Services upon execution of this Agreement. Based on a timely response from the City for requested information, Consultant shall complete the Services identified above such that the CDBG application shall be submitted to the Kansas Department of Commerce in time to meet the 2022 CDBG application filing deadline. The anticipated filing deadline is in late September 2022.
  - B. Neither the City nor the Consultant shall be in default of the Agreement for delays in performance caused by circumstances beyond the reasonable control of the non-performing party, including, but not limited to, unusually severe weather conditions, floods, tornadoes, earthquakes, fires, and epidemics; wars, riots and other civil disturbances; strikes, lockouts, and other labor disturbances; or judicial restraint. Should such a circumstance occur, the non-performing party shall, within a reasonable time, give the other party written notice describing the circumstances and

the anticipated date to resume performance of the Agreement.

- C. If Consultant's performance is delayed due to delays caused by the City, Consultant shall have no claim against the City for damages or payment adjustment other than an extension of time to perform the Services.
- 7. Services Not Included
  - A. Completion of an application for funding through the Kansas Water Pollution Control Revolving Loan Fund (KWPCRF) as administered by the Kansas Department of Health & Environment or a USDA Rural Development Loan. Engineer may provide these services under a separate agreement.
  - B. Design services, including the development of construction drawings and specifications, for the recommended improvements.



This letter is in reference to that certain Declaration of Lease dated May 1,1978 originally between the City of
