To include the following persons: Governing Body, City Manager and City Attorney if needed with the open meeting to resume in the City Commission Chamber at 6:30, seconded by Commissioner Urbanek. Motion carried 4-1 with Commissioner Donahue casting the dissenting vote. The Regular meeting resumed with no action taken.

Executive Session - Mayor Gares made a motion that the Herington City Commission recess into Executive Session, pursuant to the personnel matters of non-elected personnel exception, K.S.A. 75-4319(b)(1) in order to discuss administrative authority. To include the following persons: Governing Body, City Manager and if needed with the open meeting to resume in the City Commission Chamber at 6:35, seconded by Commissioner Urbanek. Motion carried 4-1 with Commissioner Donahue casting the dissenting vote. The regular meeting resumed with no action taken.

Police Department Update – There were 266 calls for service, 68 traffic stops and 5 arrests: 2 misdemeanor and 3 felony. To expand on Commissioner Castleberry's question from a previous meeting regarding an increase in call volume to expand on Ben's question, 66% of the department's calls are officer initiated. The police department is looking at new vehicle from Andover, would be ready in the

August/September timeframe, once final numbers are provided it will be brought to the Commission for approval. The new Officer is still on light duty. A few items were lost at the Police Department due to a power surge/lightning strike including speakers and tv's. New surge protectors have been ordered. The Police Department now has new training available to the police officers from the academy they are online classes and count towards 50% of the officers annual training requirements.

Fire Department Update – The calls for service from June 7, 2022, to July 5, 2022, were 8 medical assist, 3 motor vehicle accidents with injuries, 1 gas leak, 1 public service assistance, 2 authorized control burnings, 1 severe weather, 1 water rescue, 1 MVA with hazmat, and 1 off road equipment fire. Training hours and topics were structure drills and water rescue refresher. Nelson completed all tests and is now attending a pump operator class. One new volunteer has joined, and two were lost, still looking for more volunteers. Department and Equipment Update: Received generator light tower from Forestry, maintenance and upkeep on trucks are costly this year, issues continue on 940 and 941. Received med bags, 2 defibs and hand tools from Forestry approximately \$5500 value. The E911 committee has met. All SBCA equipment has been received and is in service. 5-year hydro testing. Kansas Forest Fire Grant submitted for 10k, should hear back if awarded or not this week. Lost some small equipment from the lightning strike as well.

Neighborhood Services Update – James has worked 14 days in Herington since July 7th. He started working in Marion on Monday June 20 for a total of 4 days worked in Marion so far. Current schedule will be Monday and Wednesday in Marion and Tuesday, Thursday, and Friday in Herington. Had roughly 40 complaints and 76 inspections. There were 53 grass inspections, resulting in 26 violation notices. Issued 16 cut orders, 7 have been mowed by the City and 6 by homeowners. Wrote 4 environmental violations including 2 fences down, 1 untagged automobile on blocks and 1 for furniture in the yard. 5 building permits were issued, 3 electrical permits with 3 inspections, 4 mechanical permits with 2 inspections 1 plumbing permit with 2 inspections and 2 fence permits. There have been 2 electrical inspections for new service and 4 structural building inspections. Still short on numbers for the BCTA board, Branden and James are working on getting the board members filled out.

Introduction of Airport Restaurant Partner – Sean Davis came and talked about his new restaurant to be located at the Herington Airport, hoping to open in mid-July, looking at being open for breakfast Monday through Friday.

Reappointment of Toby Osburn to the Herington Recreation Commission – Commissioner Bell made a motion to approve Toby Osburn for reappointment to the Herington Recreation Commission term to expire 7/31/2026, seconded by Commissioner Donahue. Motion carried 5-0.

Discussion from Ricky Dalton and Alicia Weber on Tripp Field – Mayor Gares made a motion to limit to both speakers to 10 minutes, Commissioner Castleberry seconded. Motion failed 2-3 with Commissioner Bell, Commissioner Urbanek and Commissioner Donahue casting the dissenting vote. Ricky Dalton shared his opinions about not having the mud run at Tripp Field. Alicia Weber was not present.

Presentation of the Mud Run Event by the Kansas Ram Club – Michael Hayden, president of the Kansas Ram Club presented information on why they would like to bring their mud run to Tripp Field in Herington. Michael stated that if they were not able to have the mud run at Tripp Field that they would not have the event in Herington.

Commissioner Bell left the meeting at 7:33pm.

Mayor Gares opened the meeting to guestions from the audience.

Marcia Mathias – Asked where they have hosted another event. Fort Scott was their first. Wondering about liability insurance, 1-million-dollar insurance required by Branden.

Rod Coon – 1600 West Walnut - Asked if the vehicles would be required to have a muffler. No, not required.

Jeff Biehler – 320 E Franklynn – Asked if the trucks are brought in on trailers, most are drove in, but some are trailered. One will park in field, south parking lot will be utilized. Asked Commissioners – Has anyone ever checked with the national historical society to get it deemed historical?

Fred Olsen – 416 S B – Concerned about noise and tearing up the field, thinks we are rushing into it. How many times will this event happen each year? This is a one-time event right now.

DJ Neuberger – Will the city require a surety bond be filed in case the Ram Club fails to restore the field? Mentioned the demo derby area.

Jim Biehler – E Franklynn – Longtime resident, ties to the field. How many participants? Approximately 500 spectators and 50 trucks to participate.

RESOLUTION NO. 958

A RESOLUTION GRANTING TEMPORARY EXEMPTION FROM THE REQUIREMENTS OF CHAPTER 3, ARTICLE II, SECTION 3-204 PROHIBITING CONSUMPTION OF ANY ALCOHOLIC LIQUOR OR ENHANCED CEREAL MALT BEVERAGE ON PUBLIC PROPERTY WITHIN THE CITY LIMITS OF THE CITY OF HERINGTON, DICKINSON COUNTY, KANSAS.

WHEREAS, the City of Herington, Kansas generally prohibits consumption of alcoholic liquor or enhanced cereal malt beverages on public property within the city limits; and,

WHEREAS, the governing body desires to allow for temporary exemptions from such a general prohibition by resolution lawfully approved by majority vote of the governing body; and,

WHEREAS, the governing body has received a request for exemption for a public event to be held on city property and deems it appropriate to allow for a temporary exemption.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF HERINGTON, KANSAS:

- 1. The governing body hereby finds that a temporary exemption should be granted for possession, consumption, and sale of any cereal malt beverage including enhanced cereal malt beverages defined as having an alcohol concentration of no more than 6.0% by volume and alcoholic liquor, on certain public property identified in paragraph 2 of this resolution.
- 2. The exemption shall apply only to a clearly defined, fenced and secure area in and on the an area commonly known as Tripp Field within the city limits of the City of Herington, Kansas. Such defined area as established, and any signage or surrounding security barriers identifying the prescribed area, shall be approved in advance by the Herington Police Chief.
- 3. The exemption shall be allowed on Saturday, July 23rd, 2022 from 10:00 a.m. until 10:00 p.m. and on Sunday, July 24th, 2022 from 10:00 a.m. until 10:00 p.m. at which time such temporary exemption shall expire.
- 4. Such exemption shall apply for the possession and consumption of enhanced cereal malt beverages only, defined as having an alcohol concentration of no more than 6.0% by volume.

All necessary permits authorizing the possession, and consumption of any cereal malt beverage including enhanced cereal malt beverages defined as having an alcohol concentration of no more than 6.0% by volume, shall be timely applied for and granted by the appropriate licensing agency in advance of the noted date herein as a precondition for award of this exemption.



ORDINANCE NO.1872

AN ORDINANCE AMENDING THE CODE OF THE CITY OF HERINGTON, KANSAS, TO SPECIFICALLY AMEND AND REPLACE, IN ITS ENTIRETY, CHAPTER 4, ARTICLE II, SECTION 4-201 INCORPORATING THE INTERNATIONAL ELECTRICAL CODE AND ADDING CERTAIN ELECTRICAL STANDARDS SUPPLEMENTING THE INTERNATIONAL ELECTRICAL CODE ALL REGULATING INSTALLATION, MAINTENANCE, AND USE OF ELECTRICAL SERVICES PURSUANT TO THE CODE OF THE CITY OF HERINGTON, KANSAS WITHIN THE CITY OF HERINGTON, KANSAS CHAPTER 4, ARTICLE II AND REPEALING ANY OTHER CURRENT ORDINANCES, OR PORTIONS THEREOF, IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HERINGTON, KANSAS.

SECTION 1. That Chapter 4, Article II, Section 4-201 of the Code of the City of Herington, Kansas, is hereby amended and replaced to read, in its entirety, as follows:

4-201. National Electrical Code incorporated by reference.

- (A) The standard code known as the "National Electrical Code", (Latest Edition adopted and in City Possession) is hereby incorporated by reference herein and made a part of this article, except such portions as may hereafter be deleted or amended.
- (B) When an electrical service has been inactive, terminated, or out of service in excess of one hundred eighty (180) days, the electrical service shall be brought into compliance with the currently adopted National Electrical Code as well as the City of Herington Electrical Standards adopted and applicable as follows:

CITY OF HERINGTON ELECTRICAL STANDARDS.

- 1. Meter height 5' and have a working clearance of 4' in front and 3' side to side.
- 2. Meter enclosure shall have a minimum of 30 inches of working space from the center of the enclosure on at least one side of the meter enclosure.

- 3. Gas meter shall be located 3 ft. from electrical equipment.
- 4. Meter enclosure shall be located in an area so that any building overhang is not less than 7 feet above final ground level.
- 5. The meter encloser shall be located within direct line of sight of the electric company utilities.
- 6. Only one service entrance conductor shall be allowed to each meter enclosure lug. A maximum of two sets of service entrance conductors shall be allowed in an approved meter enclosure with a connect designed for two sets of service conductors.
- 7. Disconnect required at the meter if meter encloser is more than 15' from where the service entrance conductors enter the structure.
- 8. Customer's/developer's disconnects shall be grouped at a common location.
- 9. Disconnect required at the meter encloser for underground service.
- 10. Disconnect required if meter enclosure is located on a pole/pedestal.
- 11. If service weather head is within 18" of the soffit/gable it must pass through the roof and meet the standards of the National Electric Code adopted by the City of Herington, Kansas.
- 12. Service mast shall be a minimum of 2" ridged metal conduit.
- 13. If the point of attachment to the service mast is 24" above the roof line than a guy shall be required.
 - a. Guy shall be capable of withstanding tension of the service cable
 - b. Guy clamp shall be separate from the mast service cable clamp attachment.
 - c. Guy angle shall be 45 degrees or greater
- 14. Electrical service wires passing over structures must have 8' of clearance between the structure and the service wire.
- 15. Easement around the Electrical poles shall be 10'.
- 16. Easement of primary electrical wires shall be 10'.
- 17. Underground services shall be shall in conduit 30" deep to the top of the conduit.
- 18. Underground services shall be marked with a warning ribbon 12" above the conduit.
- 19. Underground services shall have a disconnect at the meter enclosure.
- 20. Underground services shall be installed with a slip joint at the meter pole and at the house.

SECTION 2. Other ordinances, or portions thereof in conflict herewith, are hereby repealed.

SECTION 3. This ordinance shall take effect and be in force from and after its publication in the official City newspaper.
