Special Meeting with the USD487 Board of Education and Herington Recreation Commission June 8, 2022 6:30 p.m.

The meeting opened with the Pledge of Allegiance.

Call to Order – Mayor Eric Gares called the meeting to order for the Herington City Commission. President Mark Wendt called the meeting to order for USD 487, moved and seconded to approve the agenda, all in favor 6-0. Josh Lawrenz called the meeting to order for the Rec Commission, seconded by Shelly Langhofer, motion carried 5-0.

Appointed Recreation Commission Representatives – The school board recognized being involved in the appointment of Rec Commission Representatives, to try and streamline how the city is involved with appointing representatives.
