Pine tree major erosion at north park, may need to take it down. League conference, CDBG money for childcare, looking at getting local childcare provider and ransom to come present.

Robbin- Airport leases coming up on ag ground. Feb 2023 set to expire. Need to put out for bid soon. Advertise in grass and grain.

Ben- Asked about a safe walk update. Fed government is going thru applications now. Per USD 487 funds will have to come from the city, we have applied for funds, but need 1.25 million matching funds. Debi – Nothing.

Vance – West side of town 201 S 10<sup>th</sup> Street, Fence on McClaren and 9<sup>th</sup> – severe tripping housing. City is working on it. Pricing UAV for police/fire/safety departments.

### **ORDINANCE NO. 1878**

AN ORDINANCE AMENDING THE CODE OF THE CITY OF HERINGTON, KANSAS, TO SPECIFICALLY AMEND AND REPLACE, IN ITS ENTIRETY, CHAPTER 7, ARTICLE II, SECTION 7-204 SUPPLEMENTING WATER SYSTEM CONNECTIONS IN ARTICLE II OF CHAPTER 7 TO WATER SUPPLY CONTROL AND SHUT OFF VALVES REQUIREMENTS PURSUANT TO THE CODE OF THE CITY OF HERINGTON, KANSAS WITHIN THE CITY OF HERINGTON, KANSAS CHAPTER 7, ARTICLE II AND REPEALING ANY OTHER CURRENT ORDINANCES, OR PORTIONS THEREOF, IN CONFLICT HEREWITH.

# BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HERINGTON, KANSAS.

**SECTION 1**. That Chapter 7, Article II, Section 7-204 of the Code of the City of Herington, Kansas, is hereby amended and replaced to read, in its entirety, as follows:

### Sec. 7-204. - Premises to have separate connection.

- (a) Unless special permission is granted by the City Manager, each premise shall have a separate and distinct service connection, and where permission is granted for branch services, each service shall have its own shut-off or cut-off and separate meter.
- (b) Each dwelling unit shall be provided with an accessible main shutoff valve owned and maintained by the property owner at or near the entrance of the water service. The valve shall be of a full-open type having nominal restriction to flow, with provision for drainage such as bleed orifice or installation of a separate drain valve.
- (c) In the event no such shut-off valve is provided by the owner, a shut-off fee shall be assessed in the amount of twenty-five (\$25.00) dollars for each service by City utility staff both to terminate or reconnect service.
- (d) If service is disconnected, either temporarily or permanently for any City customer, at any address for a period of six months or more, where a separate shut-off valve is as required herein, no service will be reconnected until such valve has been installed.

**SECTION 2.** Other ordinances, or portions thereof in conflict herewith, are hereby repealed.

**SECTION 3.** This ordinance shall take effect and be in force from and after its publication in the official City newspaper.
