## SOLID WASTE (Ordinance 1879 passed 12/20/2022)

Weekly pickup is for three 30 gallon containers (not provided). Rate is \$20.50 per month. Senior Citizens Rate \$19.50 per month. Extra Trash is considered a special pickup for a fee. You will have to contact M & K Trash Service to make arrangements at 785-965-2211.

## UTILITY BILLING DUE DATE (Ordinance 1640 Article 4 Section 7)

Utility bills are mailed on or about the 5th of each month. That is when they are due. Penalty is added after 4:00pm on the 25th of each month unless such date is on a weekend or holiday recognized and observed by the City of Herington, in which case the payment shall be due the last business day prior to the 25th by 4:00pm to avoid penalty.

**Failure to receive the bill does not waive past due penalty.**

**Failure to receive the delinquent bill does not waive the shut off date.**
